Authorization for the University to Approve Athletic Department Summer Camp

Contracts

Background:

The University of Michigan Athletic Department allows its head coaches to operate summer camps using University of Michigan athletic facilities. Typically the right to operate a camp is part of the coach's employment contract. All responsibility for paying camp expenses, including U-M facility rental fees, payment for camp assistants, and insurance for camp activities remains with the coach. Athletics does not allow any other types of sport camps to use Athletics' facilities. Athletics provides marketing, registration processing and basic operations support for all camps.

The coaches, individually or through a company owned wholly or in part by the coach, contract with the University for use of the athletic facilities. There is a standard rental fee schedule and standard terms and conditions for athletic facility use. The contract has been approved by both Office of General Counsel and Risk Management.

The Summer Camp Contracts fall under the State of Michigan Conflict of Interest Statute as the head coaches are University employees. However, the Statute allows the University to enter into such contracts if the following conditions are met:

- a) The public servant promptly discloses any pecuniary interest in the contract to the official body which has power to approve the contract, which disclosure shall be a matter of record in its official proceedings.
- b) The agreement is approved by a vote of not less than 2/3 of the full membership of the approving body in open session without the vote of the public servant making the disclosure.
- c) The official body discloses the following summary information in its official minutes:
 - i) The name of each party involved in the contracts.
 - ii) The terms of the agreement, including duration, financial consideration between the parties, facilities or services of the public entity included in the agreement, and the nature and degree of assignment of employees of the public entity for fulfillment of the agreement.
 - iii) The nature of any pecuniary interest.

The following attachment is provided in compliance with the statutory requirements contained in Section (c) above.

The Athletic Department coaches have met state law requirements with the disclosure of this pecuniary interest.

<u>We recommend</u> that the Board of Regents approve Summer Camp Contracts between the University of Michigan Athletic Department and the head coaches as attached.
