Background:

In 2000, the University of Michigan Board of Regents and the Washtenaw County Board of Commissioners jointly created the Washtenaw Community Health Organization (WCHO) under the Urban Cooperation Act as a means to promote and achieve better coordination/integration of specialty mental health services/supports with general medical care for individuals with serious mental illness, co-occurring mental illness and substance abuse, primary addiction disorders and/or developmental disabilities. Each entity is responsible for appointing six members to the WCHO Board of Directors.

The WCHO, in association with its clinical partner, Community Support and Treatment (CSTS), retained its legacy mission, commitment and legal responsibility for persons within Washtenaw County with serious mental illness, co-occurring conditions, developmental disabilities and/or substance use disorders. The WCHO's organizational connection with the University of Michigan Health System (UMHS) provides WCHO/CSTS opportunities to establish primary care linkages for consumers, to coordinate physical/mental health care provisions, to engage in collaborative medical management arrangements, and to develop electronic health information exchange capabilities.

The WCHO strives to contribute to all of the Health System's goals and objectives and to be a resource for education and research to all schools within the University. The WCHO is a clinical placement site for third year psychiatric residents. The third year medical student rotation continues to receive the highest rating of all of the psychiatry rotations. Family practice residents rotate through an integrated healthcare site and child psychiatry fellows are placed in integrated healthcare sites and at the public community mental health center. Students from the Schools of Social Work and Nursing also receive field training at the mental health center. Additionally, the WCHO partners extensively with researchers from across the University of Michigan campus, serving as the clinical site for a number of clinical practices and outcomes.

Proposed re-appointment to WCHO for the Term: April 1, 2011 - March 31, 2014:

Mrs. Martha Bloom has been a member of the WCHO for the past two years representing the University of Michigan. During this time she served on the Finance Committee and has participated fully in discussions and actions of the Board. Ms. Bloom is a strong advocate for housing and services for individuals with disabilities. In 1990, she co-founded the Ann Arbor site of the Local Initiatives Support Organization, an organization that pools national funding with matching local funds to support the development of affordable housing in Washtenaw County. She has been a member of the Ann Arbor Area Community Foundation since 1997, and now serves as its Vice-President. As a member of the Foundation, she has been involved in initiatives such as the Blueprint to End Homelessness (Co-Chair of the Integrated Funding workgroup) and the Community collaborative of Washtenaw County (Co-Chair of the Funders Forum). She also served on the Continuum of Care Board, comprised of County Department heads, local funders, local non-profits serving the homeless, non-profit housing developers and consumers. This Board reviews local applications to HUD for homelessness prevention funds. She served as its Chair for two years. For the past three years, Ms. Bloom has worked with other parents of developmentally disabled children to create a new supported housing option, Intentional Communities of Washtenaw (ICW). The mission of ICW is to promote housing communities of choice for developmentally disabled adults, in order to reduce isolation and develop skills for independence in a community setting.

Dr. Jerry Walden is reapplying for a third term on the WCHO Board of Directors. He established and directed the Packard Clinic until his retirement in 2007. He is well known in the community for his commitment to serve Medicaid and indigent consumers as well as members of the community who are incarcerated. Dr. Walden worked closely with the WCHO in establishing the integrated health model at the Packard Clinic. His knowledge of providing physical health care is very valuable to the Board.

I recommend that the Regents approve the appointments/reappointments of the above named individuals to the Board of Directors of the Washtenaw Community Health Organization for the term April 1, 2011 -March 31, 2014.

Martha Bloom, and her husband David (Chair, Department of Urology, UMMS) have lived in Ann Arbor since 1984. She has raised a family, been an active volunteer and has worked in the nonprofit sector for 15 years. The oldest of her four children, Alex, was born with a developmental disability and has been living independently in the community since 1994. His siblings, Amy, Emily and David no longer live in Ann Arbor, but are very involved with Alex and the planning for his future.

Martha has worked to increase the stock of affordable housing since 1990. She cofounded, along with prominent businessman Bill Dobson, the Ann Arbor site of the Local Initiatives Support Organization (LISC). LISC pools national funding that match local dollars to support the development of affordable housing in Washtenaw County.

In 1997 Martha joined the staff of the Ann Arbor Area Community Foundation. She is currently Vice President and has been involved with community leadership initiatives such as the Blueprint to End Homelessness (Co-Chair of the Integrated Funding workgroup) and the Community Collaborative of Washtenaw County (Co-Chair of the Funders Forum). Martha also served on the Continuum of Care Board and was its Chair for two years. The Continuum of Care Board was comprised of County Department heads, local funders, local nonprofits serving the homeless, nonprofit housing developers and consumers. Its primary function was to review local applications to HUD for homelessness prevention funds.

For the past six years, Martha has worked with other parents of developmentally disabled children to create a new supported housing option. The mission of Intentional Communities if Washtenaw (ICW) is to promote housing communities of choice for developmentally disabled adults, in order to reduce isolation and develop skills for living in an interdependent setting. In broad terms, an intentional community is a planned residentail community with a much higher degree of social interaction than other communities. The members of an intentional community typically hold a common vision and share responsibilities and resources. Intentional Communities of Washtenaw intends to develop a range of housing options for developmentally disabled adults, based on their individual strengths and gifts, as well as their needs and personal preferences. ICW is a program of Catholic Social Services and opened its first housing community in August 2008. Currently ICW is working with eight families to develop a second site in a farmlike setting. An ICW community in Saline is being explored.

Martha is a secondary consumer of WCHO services and has represented the University of Michigan on the WCHO Board for the past three years.
