Subject: Implementation of the Regents' Policy on Openness in Research Grants, Contracts, and Agreements, FY07

A. The Regents' Policy

Regents' Policy Concerning Grants, Contracts, and Agreements, approved in 1987, addresses the principles to use in balancing open scholarly exchange and academic freedom in sponsored research agreements. By policy, the Vice President for Research consults annually with the Senate Assembly Research Policy Committee on implementation of the policy and then reports to the Regents.

B. Implementation Procedures for the Regents' Policy

The implementation procedures for the Regents' Policy,

- a) Define certain contract restrictions that are "standard" and which may be accepted directly by our research contract negotiators.
- b) Require higher-level review and approval to accept federally classified research contracts and those containing "non-standard" terms.

C. Experience during FY07

In FY07, the Vice President reviewed eleven (11) new requests for approval of contractual restrictions on openness from seven (7) different academic units, representing 0.23% of the 4,690 proposals submitted and 0.56% of the 1,950 awards accepted during that same period.

D. Policy Experience, FY88-FY07

The Vice President for Research had provided the Regents with information on the annual experience with the policy since FY88. The number of requests for non-standard restrictions is a small and relatively stable proportion of research agreements proposed or accepted by the University. The University conducts very little classified research.


