Background:

Housing and Residential Life developed the proposed rate increases for 2009-2010 in collaboration with and support of the Vice Chancellor of Administration, as well as appropriate administrative staff within the University of Michigan-Flint.

Recommended Residence Hall Rate Increase: The proposed room rate increase is 1.75%. This increase is commensurate with projected increases in the general cost of operations including funding for inflation, utilities, maintenance, etc. A summary of the Residence Hall rate recommendations is delineated by room type and is included as Attachment A.

I recommend the Regents approve the rate recommendations for FY 2010.

The 1.75% increase applies only to the room rate while board (\$2,600/yr) remains unchanged from 2008-2009.

Base price for Unit Type D (six rooms, twelve beds) was adjusted \$200 to correct for under-pricing in FY 2009.
