SUBJECT: 2006-07 Fee Assessments for Michigan Student Assembly (MSA),
Student Legal Services (SLS), and School/College Governments


ACTION REQUESTED: Approval of the following fee assessments:
\$7.19 per student per term for MSA (*no change from 2005-06*);
\$6.00 per student per term for SLS(*no change from 2005-06*);and
\$1.50 per student per term for School/College governments (*no
change from 2005-06*)

Background: At the July 2005 Regents' Meeting, the Regents authorized an increase in fee to \$7.19 per student per term for MSA and to \$6.00 per student per term for Student Legal Services. The Regent also re-authorized a fee of \$1.50 per student per term for school and college governments.

MSA, SLS and School/College Government Fees: This year, Michigan Student Assembly believes that the current fee structure will provide adequate funding for the coming fiscal year (see attached memorandum). The Division of Student Affairs believes that Student Legal Services will have sufficient resources for 2006-07 under the current fee structure. We also believe the school and college government organizations are adequately funded. Therefore, no increase is being requested for either MSA, SLS or School/College Governments.

Recommendation: I recommend approval of the following fees for 2006-2007: \$7.19 per student per term for Michigan Student Assembly, \$6.00 per student per term for Student Legal Services, and \$1.50 per student per term for school and college governments.
