Subject: Regental Action Required Under the State of

Michigan Conflict of Interest Statute

<u>Action Requested:</u> Authorization for the University to transact with Growing Forward

Together (University of Michigan Employees, Lisa Kane Low, Member of

the Board of Directors, and Julia S. Seng, Co-Founder, CEO, and

Director).

Background:

The University of Michigan Department of Obstetrics and Gynecology seeks approval to transact with Growing Forward Together for trauma-informed care training for perinatal professionals.

The proposed agreement falls under the State of Michigan Conflict of Interest Statute as Lisa Kane Low is a University employee as Professor and Associate Dean with the School of Nursing and the Department of Obstetrics and Gynecology and would be party to the contract as member of the board of directors of Growing Forward Together, and Julia S. Seng is a University employee as Professor with the School of Nursing and the Department of Obstetrics and Gynecology and would be party to the contract as co-founder, ceo, and director of Growing Forward Together.

However, the Statute allows the University to enter into such agreements if the following conditions are met:

- a) The public servant promptly discloses any pecuniary interest in the contract to the official body which has power to approve the purchase, which disclosure shall be a matter of record in its official proceedings.
- b) The purchase is approved by a vote of not less than 2/3 of the full membership of the approving body in open session without the vote of the public servant making the disclosure.
- c) The official body discloses the following summary information in its official minutes:
 - i) The name of each party involved in the contract.
 - ii) The terms of the purchase, including duration, financial consideration between the parties, facilities or services of the public entity included in the purchase, and the nature and degree of assignment of employees of the public entity for fulfillment of the purchase.
 - iii) The nature of any pecuniary interest.

The following information is provided in compliance with the statutory requirements contained in Section (c) above:

- i) The parties to the contract are the Regents of the University of Michigan and its Department of Obstetrics and Gynecology and Growing Forward Together.
- ii) The agreement is for a one time fee at a total cost not to exceed \$3,550. Growing Forward Together will be supplying all the necessary resources and personnel to fulfill this contract. The remaining base contract terms and conditions are typical to those used in Procurement Services standard templates for other similar contracts entered into by the Regents.
- iii) The pecuniary interest arises from the fact that University of Michigan employees, Lisa Kane Low, is member of the board of directors, and Julia S. Seng is co-founder, ceo, and director of Growing Forward Together.

Lisa Kane Low and Julia S. Seng have met state law requirements with the disclosure of their pecuniary interest and formal appointment arrangements with the University of Michigan. Requirements, if any, that may be applicable by the supervisors of Lisa Kane Low and Julia S. Seng, under the Medical School's or OVPR's Conflict of Interest Committee's procedures are separately analyzed and managed.

<u>We recommend</u> that the Board of Regents approve the agreement between the University of Michigan and Growing Forward Together subject to requirements, if any, that the supervisors of Lisa Kane Low and Julia S. Seng or the Medical School's or OVPR's Conflict of Interest Committee may impose.
