On the recommendation of the Executive Committee of the School of Nursing, I am pleased to recommend the appointment of Sonia Duffy as associate professor of nursing, without tenure, effective January 1, 2007.

ACADEMIC DEGREES

Dr. Duffy received a B.S. in Nursing from Wayne State University in 1978 and a M.S. in Nursing from the University of Michigan in Community Health Nursing, Home Health Care in 1985. She completed her Ph.D. in Public Health focusing in Cancer Prevention, Community Health Sciences, and Epidemiology at the University of Illinois in 1999.

SUMMARY OF EVALUATION

Her scholarly productivity has been high and shows steady output. Her publications reflect the interdisciplinary teams she has worked with. She has also produced educational materials and manuals for patients, giving indication that she is keen to bring to bear research findings to the clinical setting to improve patient care.

Dr. Duffy is an experienced investigator with a number of NIH-funded projects to her credit. Her research with quality of life in head and neck cancer patients, care and management of depressed diabetes patients, and smoking cessation address the health promotion and lifestyle issues related to illness. Throughout her research, she expresses a keen understanding of individual and family needs and the role of community resources and support. She works well in interdisciplinary teams and has collaborated with physicians, clinical and basic science researchers in addressing important clinical questions. The active participation of nursing is critical to helping patients manage their illness and Dr. Duffy is that critical link. Thus, she combines teaching, practice, and research that well suit the school's overall mission.

Dr. Duffy has had some teaching experience, although her recent teaching has been in the form of student mentorship and research supervision rather than formal teaching. Dr. Duffy is eager to return to the classroom and engage with students in their learning. She has practiced in a variety of settings in the community, particularly in home care and hospice.

PROFESSIONAL ACTIVITY


Dr. Duffy's service activities have been in connection with her research work, whereby she has been a grant reviewer and reviewer of manuscripts for several interdisciplinary journals, and has served on the Institutional Review Board of her employing institution.

On the recommendation of John F. Greden, M.D., the Rachel Upjohn Professor of Psychiatry and Clinical Neurosciences and Chair of the Department of Psychiatry, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Amy M. Kilbourne, Ph.D., as Associate Professor of Psychiatry, without tenure, effective February 15, 2007.

Dr. Kilbourne received the M.P.H. and Ph.D. degrees from the University of California at Los Angeles in 1996 and 1999, respectively. In 1999, she was appointed as Assistant Professor in the Departments of Medicine and Psychiatry at the University of Pittsburgh. She is a member of the core faculty at the Advanced Center for Intervention Services in the Department of Psychiatry at that institution. Since 2000, Dr. Kilbourne also has been a core faculty member of the Veterans Integrated Services Network (VISN 4) Mental Illness Research, Education and Clinical Center at the VA Pittsburgh Healthcare System. In 2005, she was named associate director of the Implementation Research Core, Center for Health Equity Research and Promotion, at the Pittsburgh VA facility.

Dr. Kilbourne's research has focused on the delivery of mental health services, quality improvement and integrated treatment strategies. She currently has two grants funded by the Department of Veterans Affairs that focus on measuring quality and outcomes in bipolar disorder. Her bibliography includes over 40 peer-reviewed publications in excellent journals in her field. She has been invited to present her work at national meetings and serves on national committees, including the VA Mental Health QUERI (Quality Enhancement Research Initiative) and Strategic Planning Committee on Barriers to Care.

At the University of Pittsburgh, Dr. Kilbourne has taught interdisciplinary courses in health services research methods, psychiatric epidemiology, outcomes assessment, and implementation. She devised and directed an "implementation science" course in 2005 for graduate students and medical fellows for the University of Pittsburgh and Carnegie Mellon University under the guidance of an interdisciplinary faculty from both universities. At the University of Michigan, she will teach and mentor psychology interns, psychiatric residents and postdoctoral fellows.



She is also a member of several professional organizations, including the International Society for Bipolar Disorders, Academy Health, American Association for Geriatric Psychiatry, and the American Public Health Association.



She has a well funded research program, has significant national visibility for her scholarship, and is an experienced teacher and mentor. On the recommendation of the Executive Committee of the College of Engineering and with the endorsements of the Department of Mechanical Engineering and the Department of Biomedical Engineering, I am pleased to recommend that Albert J. Shih be appointed as professor of biomedical engineering, without tenure, in the Department of Biomedical Engineering, College of Engineering, effective January 1, 2007.

Dr. Shih received both his B.S. and M.S. degrees in mechanical engineering from the National Cheng Kung University in 1984 and 1986, respectively. He earned his Ph.D. in aeronautics and astronautics engineering from Purdue University in 1991. From 1991 to 1994, Dr. Shih worked at Cummins, Inc., as senior engineer and then as technical specialist until 1998. In 1998, he joined North Carolina State University as an associate professor. In 2003, Dr. Shih moved to the University of Michigan as an associate professor and was promoted to professor in 2006.

Dr. Shih's research and teaching interests are in precision machining of advanced materials, precision machine design, optical measurements, micro electrical discharge machining (EDM), elastomer machining and scrap tire recycling, thermal management of power electronics, and medical manufacturing. Dr. Shih is the recipient of the 1999 ASME BOSS Award, 2000 NSF Career Award and the 2004 SAE Ralph Teetor Education Award. Dr. Shih is the associate editor of the *Journal of Manufacturing Science and Engineering* and the *International Journal for Manufacturing Science and Production*.

With this additional appointment, Dr. Shih is ideally suited to assist the Department of Biomedical Engineering by his active involvement with research and students. NAME: George A. Dean, M.D. Chair in Family Medicine
EFFECTIVE DATE: February 15, 2007

With the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the establishment of the George A. Dean, M.D. Chair in Family Medicine, effective February 15, 2007.

This professorship chair is made possible through a generous gift agreement from George A. Dean, M.D., and intended to support the activities of the Chair of the Department of Family Medicine. The initial appointment period of the Dean Chair of Family Medicine will be five years, and the appointment may be renewed.

Dr. Dean was one of the "founding fathers" of the Department of Family Medicine at the University of Michigan. Thirty years ago, he facilitated the creation of a unit that he and his colleagues envisioned would encourage comprehensive, compassionate care for the entire family and train future leaders in the specialty. Today, the department boasts more than 60 faculty members, a staff of 175, and five community health centers, as well as outreach initiatives and research programs. When family medicine received departmental status in 1978, after much lobbying by Dr. Dean and others, he was appointed to the academic rank of Assistant Professor. At the time, Dr. Dean said that seeing the department born was "like a baby I had delivered." An advocate for increasing the number of family physicians nationally to address a shortage in the specialty, Dr. Dean has served his profession for 51 years and still practices in Southfield, Michigan. He currently holds appointment as Clinical Associate Professor of Family Medicine at Wayne State University, where he earned his medical degree, and helped set up that school's family medicine program as well.

With Dr. Dean's support, the future leadership of the Department of Family Medicine at the University of Michigan has been solidified, and the vision he and others

brought to fruition will carry on for years to come. I am very pleased, therefore, to recommend the establishment of the George A. Dean, M.D. Chair in Family Medicine.



With the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the establishment of the Julian T. Hoff, M.D. Professorship in Neurosurgery, effective February 15, 2007.


This professorship is made possible through endowment funds from the Department of Neurosurgery and intended to support the activities of a faculty member in the Department of Neurosurgery. The initial appointment period for the Hoff Professor will be five years, and the appointment may be renewed.

Julian T. Hoff, M.D., or "Buz" as he is known to all in the Medical School, paved the way for the ascent of the University of Michigan neurosurgery program. He came to this institution in 1981 as section chief and was the first chair of neurosurgery when it received departmental status in 2001. When he arrived at Michigan to take lead of neurosurgery, Dr. Hoff found only four faculty members in place. Under his leadership, the section evolved from a unit with three neurosurgeons to an independent department in the Medical School with 14 full-time clinical faculty and five research faculty. Throughout his tenure, Dr. Hoff gained a reputation for providing the best patient care, assembling the finest faculty, and training the most talented neurosurgeons.


Dr. Hoff was named the first Richard C. Schneider Professor of Neurosurgery in 1992 and he continues to hold this distinguished title. During his tenure, Dr. Hoff has been an editorial board member for seven specialty journals, and he has been consistently funded by the National Institutes of Health. He also has held key leadership positions in several professional societies, serving as president of the American Academy of Neurological Surgeons and the American Association of Neurological Surgeons, and as chair of the American Board of Neurological Surgeons.


This professorship will honor a most distinguished educator and neurosurgeon, and will support programs in research and education in the Department of Neurosurgery. I am very pleased, therefore, to recommend the establishment of the Julian T. Hoff, M.D. Professorship in Neurosurgery.

This research professorship is made possible through a generous gift and pledge from John A. and Carla S. The professorship is intended to support a tenured faculty member in the Department of Surgery whose research is in the field of surgical diseases of the esophagus. In recognition of Mr. and Mrs. Klein's commitment to the University of Michigan and to the Department of Surgery, as well as the exceptional patient care and research



This recommendation follows a national search conducted by a search advisory committee.

From 2002-2005, Dr. Courant served as Provost and Executive Vice President for Academic Affairs, the Chief Academic and Budget Officer of the University. He has also served as the Associate Provost for Academic and Budgetary Affairs, Chair of the Department of Economics and Director of the Institute of Public Policy Studies (now the Gerald R. Ford School of Public Policy). In 1979 and 1980 he was a Senior Staff Economist at the Council of Economic Advisers in Washington, D.C. Dr. Courant holds a B.A. in History from Swarthmore College (1968), an M.A. in Economics from Princeton University (1973), and a Ph.D. in Economics from Princeton University (1974).

Dr. Courant has authored half a dozen books and over seventy papers covering a broad range of topics in economics and public policy, including tax policy, local economic development, gender differences in pay, housing, radon and public health, relationships between economic growth and environmental policy, and university budgeting systems. Currently, he is studying the economics of universities, the economics of libraries and archives, and the changes in the system of scholarly communication that derive from new information technologies. In 2005, Dr. Courant was appointed as a Distinguished Fellow of the Council on Library and Information Resources in Washington, D.C. From 1997-2001, he was a Senior Fellow of the Michigan Society of Fellows. He has also received the Excellence in Education Award from the University of Michigan College of Literature, Science, and the Arts in 1991, 1992, 1993, and 1994. He is a Board Member and Treasurer for the Center for Watershed and Community Health. He has served on the Land Economics Editorial Board and as a member of the Policy Council for the Association of Public Policy Analysis and Management. His memberships include the American Economic Association, the Association of Public Policy Analysis and Management, and the National Tax Association.

I am extremely pleased that Dr. Courant is assuming the leadership of the University libraries at a time of complex problems that libraries face in the transition from print-on-paper collections to digital repositories. He brings knowledge and insight into the complexities of the academic environment of which the libraries are an absolutely critical part. His knowledge about copyright, digital course resources, research support, and partnerships between faculty and libraries will add to the quality of services the Library offers students and faculty. His vision offers the University of Michigan the opportunity to lead the discussion about the role of university libraries for the next generation. Professor Smock's responsibilities in this position will include assisting OVPR in its administration and oversight of the research and creative activity in the social sciences and humanities arena, providing leadership for OVPR in new initiatives, oversight and involvement with OVPR units where appropriate, and serving as a member of the senior OVPR administrative staff. She will provide leadership of task forces, development of initiatives, study of policy issues, resolution of problems, and participation in the evaluation of proposals. She will also play a key role in fostering special interdisciplinary projects. Beyond these duties, she will provide assistance in discharging the duties of the vice president in regards to research at the University of Michigan.


Professor Smock earned both her B.A. degree in 1983 and her M.A. degree in 1987, from the University of Chicago. She completed her Ph.D. in sociology from the University of Wisconsin in 1992 and joined the Department of Sociology at Louisiana State University as assistant professor in September 1992. Professor Smock joined the University of Michigan faculty in 1994 as assistant professor in the Department of Sociology and Women's Studies and as research associate in the Population Studies Center. She was promoted to associate professor and research associate professor in 2000 and attained the rank of professor and research professor in 2006. Her scientific activities include service on editorial boards, leadership positions in professional associations, membership on National Science Foundation and National Institutes of

Health review panels, ad hoc reviewer for many leading scientific journals, and membership and board positions in multiple professional societies.

Professor Smock is a sociologist and demographer, running an active research program focused on family patterns and change in the United States. She has received extra-mural funding from the National Institute for Child Health and Human Development for research projects on non-resident fatherhood, unmarried cohabitation, and, most recently, to support a five-year effort to integrate family and fertility surveys spanning five decades. This project will result in a publicly available resource aimed to facilitate new insights into changes in fertility and the family. Professor Smock has served as the associate director of the Institute for Social Research as well as associate director and training director of the Population Studies Center. Additionally, she has served as a board member and expediting chair for the Behavioral Sciences Institutional Review Board.

Professor Smock's administrative experience at the University, her extensive participation in major departmental, college, and university committees, her active involvement in sponsored research activities, and her commitment to multidisciplinary collaborative research, make her an outstanding candidate for the position of Associate Vice President for Research – Social Sciences and Humanities in the Office of the Vice President for Research. We are very pleased that Professor Smock has agreed to serve in this capacity and we strongly recommend her appointment.
