Subject: Regental Action Required Under the State of

Michigan Conflict of Interest Statute

Action Requested: Authorization for the University to enter into an agreement with the Institute of

Social and Environmental Research-Nepal (University of Michigan Employee

Dr. Dirgha Ghimire, Director and Member of the Board of Directors)

Background:

The University of Michigan Institute for Social Research through its Population Studies Center seeks approval to enter into an agreement with the Institute for Social and Environmental Research-Nepal ("ISER-N") to provide services in support of the University of Michigan research project titled "Family Migration Context and Early Life Outcomes."

The proposed agreement falls under the State of Michigan Conflict of Interest Statute as Dr. Dirgha Ghimire, Associate Research Scientist, Population Studies at the Institute for Social Research and Faculty Associate at the Survey Research Center will serve as Principal Investigator at the University of Michigan and would be party to the agreement as the Director and Member of the Board of Directors of ISER-N.

However, the Statute allows the University to enter into such agreements if the following conditions are met:

- a) The public servant promptly discloses any pecuniary interest in the contract to the official body which has power to approve the purchase, which disclosure shall be a matter of record in its official proceedings.
- b) The purchase is approved by a vote of not less than 2/3 of the full membership of the approving body in open session without the vote of the public servant making the disclosure.
- c) The official body discloses the following summary information in its official minutes:
 - i) The name of each party involved in the contract.
 - ii) The terms of the purchase, including duration, financial consideration between the parties, facilities or services of the public entity included in the purchase, and the nature and degree of assignment of employees of the public entity for fulfillment of the purchase.
 - iii) The nature of any pecuniary interest.

The following information is provided in compliance with the statutory requirements contained in Section (c) above:

- i) The parties to the contract are the Regents of the University of Michigan and its Institute for Social Research and ISER-N.
- ii) The agreement funds the ISER-N to design and conduct a survey of the local population in Nepal. Specifically, it will provide the University with administrative and logistical field support, data, and assist with data analysis. The project is sponsored by Arizona State University. Contingent upon receiving funding for the duration of the project, the agreement will continue for five (5) years and has an estimated cost of \$213,490.
- iii) The pecuniary interest arises from the fact that University of Michigan employee Dr. Dirgha Ghimire is a Director and Member of the Board of Directors of ISER-N.

Dr. Dirgha Ghimire has met state law requirements with the disclosure of his pecuniary interest and formal appointment arrangements with the University of Michigan. Requirements, if any, that may be applicable under the Medical School's or OVPR's Conflict of Interest Committee's procedures are separately analyzed and managed.

<u>We recommend</u> that the Board of Regents approve the agreement between the University of Michigan and ISER-N subject to requirements, if any, that either the Medical School's or OVPR's Conflict of Interest Committee may impose.
